**LOCAL GOVERNMENT ORDINANCE, 1961  
(Sabah No. 11 of 1961)**

**UNIFORM (LICENSING THE USE OF PREMISES FOR TRADE, BUSINESS,  
INDUSTRY AND PROFESSION) BY-LAWS 2022  
(G.N.L 17 of 2023)**

In exercise of the power conferred by section 50A of the Local Government Ordinance 1961, the Minister of Local Government and Housing makes the following By-laws:

**Citation, commencement and application**

1. (1) These By-laws may be cited as the Uniforms (Use of Premises for Trade, Business, Industry and Profession) By-Laws 2022.

(2) These By-laws come into operation on the date of its publication in the *Gazette*.  
[05-10-2023]

(3) These By-laws shall be applicable to the whole area under the jurisdiction of the Local Authority.

**Interpretation**

2. In these By-laws, unless the context otherwise requires -

“Local Authority” means an Authority as defined in section 2 of the Local Government Ordinance (Sabah No. 11 of 1961);

“business” means any trade, business, industry or profession as specified in the Schedule;

“business premises” means a premises which is used to operate a business;

“licence fee” means the prescribed payment rate for a licence issued under these By-laws as specified in the Schedule;

“nuisance” has the same meaning as assigned to it in section 3 of the Local Government Ordinance (Sabah No. 11 of 1961);

“premises” includes any house, shop, store, room, cubicle, shed, conveyance or any building or structure or any place whether open or enclosed and whether permanent or temporary.

**Licence required**

3. (1) No person shall use any premises for any trade, business, industry or profession as prescribed in the Schedule without a valid licence issued by the Local Authority.

(2) Any person who contravenes paragraph (1) commits an offence.

### **Application for licence**

4. (1) An application for a licence shall be made to the Local Authority in such form and manner as the Local Authority may determine.

(2) The application under paragraph (1) shall be accompanied by such documents or information as the Local Authority may consider necessary and relevant to the application and the Local Authority may, orally or in writing at any time after receiving the application before it is determined, require the applicant to provide such additional documents or information as the Local Authority considers necessary.

(3) The applicant shall make payment of a processing fee as prescribed in the Schedule upon submission of the application and the fee paid shall not be refundable irrespective of whether or not the application is approved by the Local Authority.

(4) The Local Authority may, after receiving an application for a licence under paragraph (1) approve the application or refuse to approve the application.

(5) Where an application for a licence is approved by the Local Authority, the Local Authority shall issue the licence subject to -

- (a) payment of a deposit as provided in by-law 8;
- (b) payment of a licence fee as prescribed in the Schedule; and
- (c) such conditions as the Local Authority thinks fit to impose.

(6) The licence fees payable are classified in accordance with the categories of Local Authority as specified in the Schedule.

(7) A Local Authority may issue a licence for a period not exceeding 5 years from the date of issuance.

(8) Where the Local Authority refuses to approve the application, the Local Authority shall inform the applicant by a written notice that the application has been refused.

(9) The Local Authority may, from time to time and while a licence is still in force, impose any additional conditions on the licensee or amend or revoke any conditions specified in the licence by giving a written notice to the licensee.

### **Form of licence**

5. A licence issued under these By-laws shall be in any form as may be determined by the Local Authority.

### **Compliance with conditions and restrictions**

6. (1) The licensee shall comply with the conditions and restrictions imposed by the Local Authority under these By-laws.

(2) Any licensee who contravenes paragraph (1) commits an offence.

**Licence fee paid not refundable**

7. Any licence fee paid under these By-laws shall not be refundable.

**Deposit**

8. (1) The Local Authority may require any person to whom a licence is issued to pay a deposit of such sum as the Local Authority may determine to ensure that the conditions of the licence and the provisions of these By-laws are duly observed.

(2) If there is a breach of any of the provisions of these By-laws, or conditions of the licence, the Local Authority shall give a notice to the licensee within the time specified in the notice to give representation as to why his deposit shall not be forfeited.

(3) The Local Authority may, after considering the representation given by the licensee or if the licensee fails to make a representation, decides either to forfeit the deposit in whole or in part of the deposit.

(4) Subject to paragraph (3), the Local Authority may require the licensee to replenish the amount of the deposit that has been forfeited.

(5) The deposit paid shall, unless forfeited, be refunded to the licensee with no adjustment for interest on the amount deposited under paragraph (1) after the licensee has ceased business operation.

(6) Where the licensee has ceased business operation, the licensee may apply to the Local Authority from the date of cessation of business operation for his deposit to be refunded.

**Replacement of licence**

9. If the Local Authority is satisfied that a valid licence issued under these By-laws is lost, defaced or damaged, the Local Authority may issue a replacement licence upon payment of the processing fee as prescribed in the Schedule.

**Transfer of licence**

10. (1) No licensee shall transfer his licence to any person except with the prior written approval of the Local Authority.

(2) An application for the transfer of a licence shall be made in such form and manner as the Local Authority may determine.

(3) A processing fee as prescribed in the Schedule shall be paid upon submission of the application and the fee paid shall not be refundable irrespective of whether or not the application is approved by the Local Authority.

**Renewal of licence**

11. (1) A licensee may apply for a renewal of his licence at any time before the date of expiry of his licence and shall be made in such form or manner as may be determined by the Local Authority.

(2) The Local Authority may, after receiving an application for renewal of licence under paragraph (1), renew the licence or refuse to renew the licence.

(3) Where an application for a renewal of licence is approved by the Local Authority, the licence shall be renewed upon payment of a fee as prescribed in the Schedule and the Local Authority may impose such conditions as the Local Authority thinks fit to impose.

### **Revocation of licence**

**12.** (1) The Local Authority may revoke a licence issued under these By-laws if the Local Authority is satisfied that -

- (a) the licensee has contravened any of the provisions of these By-laws, conditions or restrictions of the licence; or
- (b) the licensee has been convicted of an offence under these By-laws.

(2) The revocation of a licence under paragraph (1) may be made by the Local Authority without any payment of compensation to the licensee and the Local Authority may forfeit the deposit paid under by-law 8.

(3) Before a licence is revoked, the Local Authority shall give a notice in writing to the licensee requiring him to make a representation within the period as specified in the notice as to why his licence shall not be revoked.

(4) After the expiry of the period specified in the notice under paragraph (3) and after considering the licensee's representation or if the licensee fails to make a representation, the Local Authority shall proceed to consider such matter and inform the licensee by a written notice of its decision.

(5) If the Local Authority decides to revoke the licence, the revocation of the licence shall take effect on the date specified in the notice served on the licence under paragraph (4).

(6) Any person who continues his business operation after his licence is revoked under paragraph (5) commits an offence.

### **Display of licence**

**13.** (1) A licensee shall display his licence in a conspicuous place on his business premises.

(2) Any licensee who contravenes paragraph (1) commits an offence.

## **GENERAL PROVISIONS**

### **Prohibition**

**14.** (1) No licensee shall -

- (a) allow any gambling, immoral activities or any conduct which are likely to cause nuisance or disturbance to the residents within the surrounding area of his business premises;

- (b) allow any animal to remain on his business premises unless the premises has been licensed for the purpose of providing a service relating to animals; or
- (c) carry out any business activity on his business premises other than the business activity specified in his licence.

(2) Any licensee who contravenes paragraph (1) commits an offence.

#### **Sanitary requirements and maintenance of the business premises**

15. (1) The licensee shall -

- (a) ensure that all mechanical or electrical equipment which is used in his business premises is maintained in good condition and safe to be used at all times;
- (b) keep all areas and forecourts forming part of his business premises to be in a clean condition;
- (c) provide sufficient refuse bins on his business premises; and
- (d) provide sufficient toilet facilities and ensure that the toilet is in a clean condition and good repair at all times.

(2) Any licensee who fails to comply with paragraph (1) commits an offence.

#### **Disposal of refuse**

16. All refuse shall be placed in plastic bags or any other suitable containers before being deposited into refuse bins or receptacles and shall be disposed of in such manner as may be determined by the Local Authority.

#### **Spilling of noxious liquid or refuse**

17. (1) No licensee shall cause any noxious liquid or refuse relating to his business activity to be thrown, discarded, spilled, left or scattered in any public place.

(2) Any licensee who contravenes paragraph (1) commits an offence.

#### **Water supply**

18. (1) A licensee shall not use any water other than water from the public water supply or such water supply as may be permitted by the Local Authority.

(2) Any licensee who contravenes paragraph (1) commits an offence.

#### **Ventilation and lighting**

19. (1) The licensee shall ensure that -

- (a) there is sufficient and suitable lighting within his business premises;

- (b) there is sufficient ventilation within his business premises; and
  - (c) every staircase, passage, exit and emergency exit forming part of his business premises is provided with sufficient lighting.
- (2) Any licensee who contravenes paragraph (1) commits an offence.

### **Fire prevention requirements**

20. (1) The licensee shall ensure that -
- (a) adequate fire fighting equipment and adequate staircases and exits are provided and maintained to the satisfaction of the appropriate authority and the Local Authority.
  - (b) all staircases, passages, landings and exits are kept clear of obstructions; and
  - (c) every door is constructed and fitted as to be readily opened at all times.
- (2) The Local Authority may, by notice in writing instruct the licensee to comply with the requirements under paragraph (1) within the period specified in the notice.
- (3) Any licensee who fails to comply with paragraph (1) or the notice issued under paragraph (2) commits an offence.

### **Storage**

21. (1) All materials shall be stored in such manner and state as to prevent the emission of noxious matter or discharge of offensive effluent therefrom.
- (2) Any licensee who contravenes paragraph (1) commits an offence.

### **Prohibition against burning**

22. (1) The licensee shall not burn or cause to be burnt any refuse or materials or other waste generated on his business premises except in such manner and at a place approved by the Local Authority.
- (2) Any licensee who contravenes paragraph (1) commits an offence.

### **Spreading of dust, etc.**

23. (1) The licensee shall not cause, let, allow or permit any spreading of dust, fume, vapour, gas, heat, radiation, odour, smell, vibration, smoke or soot from his business premises which in the opinion of the Local Authority is a nuisance.
- (2) Any licensee who contravenes paragraph (1) commits an offence.



### **Business operating hours**

24. (1) The Authority may direct a business activity to be operated on the business premises within the period and time as specified by the Local Authority and the licensee shall comply with such direction.

(2) Any licensee who contravenes paragraph (1) commits an offence.

### **Compounding of offences**

25. (1) The Local Authority or its authorised officer may compound any offence committed by any person under these By-laws by making a written offer to the person suspected of committing the offence to compound the offence for a sum not exceeding five thousand ringgit within the time specified in the offer.

(2) An offer under paragraph (1) may be made at any time after the offence has been committed, but before any prosecution for it has been instituted, and if the amount specified in the offer is not paid within the time specified in the offer or within such extended period as the Local Authority may grant, prosecution for the offence may be instituted at any time after that against the person to whom the offer is made.

(3) If an offence has been compounded under paragraph (1) and paid, no prosecution shall after that be instituted at any time after that against that person to whom the offer to compound was made and paid.

### **Penalty**

26. Any person who contravenes any provision of these By-laws commits an offence and shall, upon conviction, be liable to a fine not exceeding one hundred thousand ringgit or to imprisonment for a term not exceeding one year or to both, and in the case of a continuing offence, to a fine not exceeding five thousand ringgit for each day during which the offence is continued after conviction.

### **Non-application**

27. These By-laws shall not apply to any premises which is required to be licensed under -

- (a) any by-laws, except this by-laws made under the Local Government Ordinance 1961 (Sabah No. 11 of 1961);
- (b) any by-laws made under the Public Health Ordinance 1960 (Sabah No. 7 of 1960); or
- (c) any rules made under the Public Entertainment Ordinance 1958 (Sabah No. 23 of 1958).
