

RURAL GOVERNMENT ORDINANCE
(Cap. 132)

BEAUFORT DISTRICT COUNCIL (TAMU) BY-LAWS 1959
(G.N.S 47 of 1959)

In exercise of the powers conferred upon it by section 15 (1) of the Rural Government Ordinance, the Beaufort District Council has made the following by-laws:

Title.

1. These by-laws may be cited as the Beaufort District Council (Tamu) By-laws 1959 and shall apply to all tamu established in the Beaufort District Council area.

Interpretation.

2. In these By-laws —

“tamu” means any of the open-air markets established by the Beaufort District Council at the following places —

Weston Tamu Ground
Bukau Tamu Ground
Gadong Tamu Ground
Padas Damit Tamu Ground
Limbawang Tamu Ground
Kota Klias Tamu Ground
Takuli Tamu Ground.

Licence.

3. No person shall sell any commodity in any tamu without a licence which may be issued by the Chairman of the District Council in his discretion, and subject to such conditions as he may see fit to impose.

Appeal.

4. Any person whose application for a licence has been refused may appeal to the District Council at its next meeting and the decision of the District Council shall be final.

Fees.

5. The following fees by way of stallage shall be paid for licences issued under by-law 3

| (c) for a licence to sell otherwise than from a stall, fruits, vegetables, dried or fresh fish, betel-nut, salt, cakes and other local products | Free. |
| (d) for any other licence | RM5.00 per month or part thereof. |

Tamu Master.

6. The District Council may appoint any person to be a Tamu Master for any tamu, who shall be charged with the keeping of order in and the general management of the tamu.

Penalty.

7. Any person who —

- (a) sells any commodity in any tamu without a licence issued under these By-laws;
- (b) takes or attempts to take into any tamu any intoxicating liquor;
- (c) has in his possession in any tamu any fireworks, firearms, or offensive weapon; or
- (d) being a licence holder fails to comply with any lawful direction of the Tamu Master,

shall be guilty of an offence against these By-laws and shall on conviction be liable to a fine not exceeding twenty-five ringgit or one month's imprisonment and on a second or subsequent conviction, to a fine not exceeding fifty ringgit or two months' imprisonment.
