

# THE FEES ENACTMENT, 1981

## THE FEES (SEPILOK ORANG UTAN REHABILITATION CENTRE) ORDER 1992

In exercise of the powers conferred upon him by section 2 of the Fees Enactment, 1981 [*Enactment No. 27 of 1981.*], the Yang di-Pertua Negeri has made the following Order:

### 1. Citation and commencement.

This Order may be cited as the Fees (Sepilok Orang Utan Rehabilitation Centre) Order 1992, and shall be deemed to have come into force on 1st January, 1992.

### 2. Fees Charged or Levied.

There shall be charged or levied by the Director of Wildlife Department:

- (a) For admission into the Sepilok Orang Utan Rehabilitation Centre of persons mentioned in the First Column in Part I of the Schedule the fees specified in the Second Column in the same part of the Schedule;
- (b) For use in the Sepilok Orang Utan Rehabilitation Centre of the photographic or video equipment mentioned in the First Column in Part II of the Schedule the fees specified in the Second Column in the same Part of the Schedule.
