THE LOCAL GOVERNMENT ORDINANCE, 1961 (Ordinance No. 11 of 1961)

LABUAN TOWN BOARD (FOOD AND EATING PREMISES) BY-LAWS, 1968

In exercise of the powers conferred upon it by section 50 of the Local Government Ordinance, 1961 [*Ord. No. 11 of 1961.*], the Labuan Town Board (hereinafter referred to as the Board) has made the following By-laws:-

Title and commencement.

1. These By-laws may be cited as the Labuan Town Board (Food and Eating Premises) By-laws, 1968, shall come into operation on the 1st day of July, 1968.

Licences.

2. No person shall carry on the business of a cookshop, eating shop, coffee shop, food stall, restaurant or bakery except in accordance with a licence granted by the Board.

Application for licence.

3. An application for a licence shall be in writing and shall be accompanied by two photographs of the applicant.

Grant of licence.

4. The Board may, in its absolute discretion, grant or refuse a licence, or grant a licence subject to such conditions as it thinks fit. Such licence shall be in the form of the First Schedule to these By-laws.

Health certificate.

5. (1) An applicant for a licence or for a renewal shall forward a certificate of health in the form of the Second Schedule hereto from a Government Medical Officer or registered medical practitioner. Such certificate shall be endorsed by the Government Medical Officer or a registered medical practitioner annually, or more often, if so required by the Board.

(2) All persons engaged on the licensee's premises, shall likewise produce certificates of health as in the manner set out in By-law 5 (1).

Duration of Licence.

6. Every licence granted under these By-laws shall be quarterly and shall expire on the 31st day of March, 30th day of June, 30th day of September or the 31st day of December, as the case may be, of each year.

Fee.

7. The monthly fee for a licence in respect of the following shall be as follows :-

Premises.

8. No premises shall be used for food or eating premises unless the construction, lighting, ventilation, drainage, sanitation, water supply and equipment are adequate and to the satisfaction of the Board.

Licence not to be transferred.

9. No licensee shall transfer or otherwise part with the possession of his licence to any person.

Penalty.

10. Any person who contravenes any of the provisions of these By-laws shall be guilty of an offence and shall be liable to a fine of one hundred dollars and for a continuing offence a fine of twenty-five dollars for everyday during which the offence is continued.

Cancellation of licence.

11. The Board may cancel or suspend a licence.

- (a) if the licensee or any assistant or employee of the licensee —
- (i) is convicted of any offence under these By-laws; or
 - (ii) is convicted of any offence under any written law relating to public health or the use of false weights or measures in respect of goods to which the licence relates; or
- (b) if, on the certificate of a Government Medical Officer or a registered medical practitioner, the licensee is suffering from a contagious or infectious disease;

(c) if, on the certificate of a Government Medical Officer the premises are insanitary or a danger to public health.

Repeal and Replacement. [See L. 20/68.]

12. Part of the Labuan Town Board (General) By-laws, 1957 is repealed.
